I am Arunachalam from Bangalore.

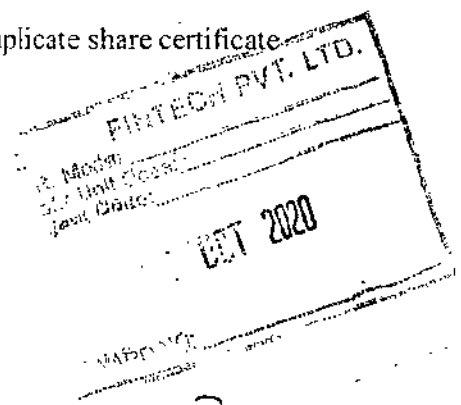
I am a shareholder in HERO HONDA MOTORS LTD since IPO. My folio no is HH 55994 (original company).
